1. Scope of Works:

2. The Terms and Conditions:


- Feeding with live worms-every alternative day.
- Change of water as and when required and change of fish as and when required.
- Add medicines as and when required.
- Cleaning of glass as and when required.
- Cleaning of aquarium grovel as and when required.
- Cleaning of rocks and corals as and when required.
- Cleaning of aquarium imported plants as and when required.
- Maintenance of aquarium equipment-always as and when required.
- Up keep of water level as and when required.
- Repairing of aquarium accessories as and when required.
- Change of filter Media as and when required
- Keeping sufficient live fish in aquarium. The fish should be different varieties and colour.
- Dead fish should be removed immediately and replace with live fish.
- To attend the complaint within 24 hours failing which penalty may be imposed of RS 100/day.
- Agency shall checkup instrumentation and control system of aquarium and takes remedial action for keeping the system round the year.



- **Mode of payment :-**The firm shall submit the monthly bills in triplicate for consolidated quarterly/payment as per the agreed rate. The payment is subject to providing satisfactory services at all time.
- The rate quoted by the firm are including replacement of components whenever required and no extra payment will be made for replacement of required components.
- The company shall not directly or indirectly employ any person of the agency during the period of contract or thereafter under any circumstances. Tenderer will comply with all the social welfare legislation for its staff more particularly the rules and regulation relating to social security (EPF) medical benefits (ESI) etc., at his/her own cost as may be required and acts of Central Govt., State Govt. and that of NCT Delhi relating to this contract.
- The staff provided should be experienced and well equipped with equipment's, accessories and other materials needed in operation and maintenance and other services.
- In case of tie in financial bid (L-1 rate), the contract will be awarded to those firm who have maximum years of experience.
- The firm will appoint a supervisor/worker for day to day monitoring, feeding and maintenance of aquarium.
- **EMD of RS 2000/-** In form of Demand Draft /PO/Cheque in favour of **DIRECTOR JSSHS** should be accompanied along with quotations. The EMD should be valid for a period of 90 days beyond the last date of submission of quotations and will be returned to unsuccessful firms after the submission of Performance security by the succesfull bidder.
- EMD shall be forfeited in case successful bidder fails to abide by the terms and conditionr or refuse to undertake the contract. The amount of EMD shall not carry any intrest.
- **Performance Security-** Successful firm should submit performance security @ **10% of annual value of contract in form of bank guarantee in favour of Director JSSHS**, New Delhi. Performance Security will be returned after completion of all obligations and termination/expiry without any interest thereon.
- After finalization of the tender, successful firm/agency would be invited to execute the Annual maintenance contract agreement.






