RECRUITMENT NOTICE FOR CONSULTANTS

Janakpuri Super Speciality Hospital (JSSH) is an Autonomous Institute and is registered as a Society under the Society Act under Government of National Capital Territory of Delhi. This institute is customer and eco-friendly and caters to close to 4,50,000 Outdoor patients (OPD) per year along with Indoor facilities.

The Employees of JSSH are committed and believe in quality services.

The facilities available in the hospital include :

- ❖ NABL accredited Laboratories with complete automation. The Laboratory Information System (LIS) is in place and the patients can access digitally signed PDF reports through URL sent to them via SMS.
- ❖ Non-invasive cardiology facilities like Echocardiography (Trans-thoracic and Transoesophageal Echocardiography), TMT, Long-term Holter monitoring, Head Up Tilt Test (HUTT) and Pulmonary Function Tests.
- ❖ International standard Cardiac Cath Lab with facilities of Angiography, Balloon Angioplasty, Stenting, Temporary and Permanent Pacemaker placement and Intra cardiac device implantation.
- ❖ Upper and Lower GI Endoscopy services.
- ❖ Neurodiagnostic services like EEG, Electromyogram (EMG), Nerve Conduction Velocity (NCV) studies, Sleep study and Video Epilepsy Monitoring.
- ❖ Dialysis unit with 31 dialysis stations equipped with latest machines. The dialysis unit performs 130 to 135 haemodialysis sessions every day.
- ❖ Senior-senior Citizen Clinic where all facilities are available under one roof on the ground floor of the hospital for individuals above the age of 70 years.

Continuing Medical Education programs and Public Education Awareness sessions are regularly organized in the Institute.


Applications are invited for engagement of retired Doctors to fill up 20 vacant posts of Faculty and Specialist Gr. III purely on Contract Basis in Janakpuri Super Speciality Hospital, New Delhi. The details regarding name of the post(s), number of vacancies, educational qualifications, experience required, consolidated amount, age limit etc. and terms & conditions are mentioned below

1. Name of Post : Consultant (Retired Faculty and Non Teaching Specialist)
2. Number of Posts : 20 (13 Faculty + 07 Non Teaching Specialist)
3. Monthly remuneration : (Last Pay drawn minus-Basic Pension) + DA per month
4. Essential Educational Qualification & Age : As per RRs of the post (Annexure A/1 –A/19)
5. Age limit : Maximum 70 years.
6. Mode of Selection : By interview
7. Submission of Application : Till 15.03.2024 upto 4:00 PM.
8. Date/venue of Interview : Shall be intimated after scrutiny of applications.
9. Duly completed applications in all respect (alongwith all supporting documents) must reach office of Director, Janakpuri Super Speciality Hospital, New Delhi-110058 latest by 15.03.2024 by 4:00 PM. Incomplete applications or application received late shall be summarily rejected.
10. The engagement of retired employee shall be governed as per terms and conditions mentioned in H&FW Department letter dated 25.08.2017, 13.10.2017, 31.01.2019, 01.05.2019 and Finance Department, GNCTD OM No. 20/4/2015-AC/204-248 dated 04.12.2015. The Terms & Conditions are as under:-
 - (a) The engagement of retired Government servant as Consultant is against a vacant sanctioned post. The engagement of consultant would be on full-time basis and they would not be permitted to take up any other assignment during the period of consultancy.
 - (b) The engagement of consultant shall initially be for a period of one year or till appointment of regular incumbent, whichever is earlier. However, it can be extended further subject to the satisfactory performance of the consultant and depending upon the specific job and the time frame for its completion. The total period of engagement as consultant shall not exceed 5 years. The maximum age limit of engagement as consultant shall be 70 years.
 - (c) The amount of monthly consolidated remuneration/fee in the case of retired Government officials appointed as Consultants shall be last Pay minus Basic Pension plus DA at the applicable rate. However, a retired Government official appointed as Consultant shall continue to draw pension and the dearness relief thereon during the period of his engagement as Consultant. His/her engagement as consultant shall not be considered as a case of re-employment.
 - (d) The Consultants shall not be entitled to any allowance such as House Rent Allowance, reimbursement of call charges of Residential Telephone/mobile, Transport facility, Residential Accommodation, Personal Staff, etc.
 - (e) No Governments vehicle shall be provided to the Consultants.
 - (f) No TA/DA shall be admissible for joining the assignment or on its completion. Consultants will not be allowed foreign travel at Government expenses. However, consultants shall be allowed TA/DA for their travel inside the country in connection with the official work, if any, as per their entitlement as on the date of retirement.
 - (g) Consultants shall be eligible for 8 days leave in a calendar year on pro-rata basis. Therefore, a consultant shall not draw any remuneration in case of his/her absence beyond 8 days in a year (calculated on pro-rata basis). Also unavailed leave in a calendar year cannot be carried forward to next calendar year.
 - (h) The engagement of consultants is of a temporary nature and the engagement can be cancelled at any time by the department/autonomous body/PSU/grant-in-aid institution concerned without assigning any reason.

- (i) The retired employee to be engaged as consultant should be clear from vigilance angle.
 - (j) The engagement can be terminated by the consultant by giving one month's notice or by paying one month consolidated amount.
 - (k) The retired employee shall not be entitled to any benefit of provident fund, pension, gratuity, seniority which are available to the Government Servant appointed on regular basis.
 - (l) These retired employee shall not be entitled to LTC for the duration of the contract.
 - (m) This engagement is purely on contract basis and will not bestow upon him/her any claim for regular appointment.
 - (n) The appointee shall bear full responsibility of the work as prescribed in the duties. In addition, he/she will also be required to discharge the duties as and when required by any authority so authorized.
